



MY26 Spring Early Renewal Campaign Incentives

Official Rules

ELIGIBILITY AND GUIDELINES: The contest is open to all currently registered members of Girl Scouts of Oregon and Southwest Washington and their parents or caregivers. The contest is subject to all federal, state, and local laws. Void where prohibited.

HOW TO ENTER: The early renewal campaign runs from April 1, 2025, through May 31, 2025.

- 1) Any adult or youth member who renews between April 1, 2025, and April 15, 2025, will be automatically entered into a raffle for one (1) of the following prizes: \$50 property credit (three (3) available), \$50 retail store credit (three (3) available), One (1) troop (or Juliette) camp experience (one (1) available).
 - a) Winners will be selected by randomized raffle drawing no later than June 30, 2025. Winners will be contacted directly by July 15, 2025. Prizes are redeemable as of July 15, 2025.
 - b) Prizes will be randomly assigned.
 - c) One (1) entry per person. No member may win more than one (1) prize.
- 2) Troops who renew at least 5* of their youth Girl Scouts and at least two (2) troop volunteers between April 1, 2025, and April 30, 2025, get the value of two (2) adult memberships (\$60) applied as a credit to the GSOSW-affiliated troop bank account.
 - a) *Or all youth Girl Scouts and two (2) adults in troops in good standing with less than five (5) youth Girl Scout members.
 - b) Troop eligibility will be confirmed by June 30, 2025, and fund transfers will be processed by July 15, 2025.
 - c) A troop must have a GSOSW-affiliated troop bank account to be eligible to receive this incentive.
 - d) Each troop can only receive the incentive once during this campaign, regardless of the number of youth or adults renewed.
- 3) All youth Girl Scouts renewed between April 1, 2025, and May 31, 2025, will receive a renewal patch.
 - a) The renewal patch will be distributed by August 1, 2025.

PRIZE AND SELECTION: This contest is administered by, and incentives supplied by, Girl Scouts of Oregon and Southwest Washington. Prizes are non-exchangeable and are not redeemable for cash or other prizes.
